

APCM REPORTS FOR 2023/2024

RECTOR'S REPORT

People

This has been a year of upheaval and change as Mary left in April and I took over in December. We also lost Paul the Pioneer, and gained Jane Eastell who, along with the ever-faithful Maureen, has joined us as a retired priest.

As ever, the churchwardens have been magnificent and tireless and I would like to thank them all: Ann and Paul, Diana, Jan and Sally and Pearl. Along with the PCCs and the regular worshipers, they/you are all superb at liaising between church and community and ensuring the profile of the 4 churches remains high.

In addition, of course, I need to mention Michele, who always gives more hours than she should and is often the first face of the church that people see. Her professionalism and pastoral excellence are a huge asset to our work in the benefice.

The Mary Joslin Trust has continued to support the work of the benefice and we are immensely grateful for their on-going and very generous funding towards our costs, without which we would really struggle.

West Monkton has now had a full year of weekly services and we are hugely indebted to Rosie and Peter for keeping worship going there, assisted by 'regular visitors' Ruth Cook and Munna Mitra as well as the worship team who meet frequently to prepare services.

The other great act of faith each Sunday is trying to get music for the services. Paul (Broomfield), Hilary (Cheddon), Dorothy (KSM) and Pearl (WM) have striven all year to try to ensure we have the cover we need and, again, we are grateful to our regular visitors who keep us going. Choral Evensong at KSM continues to be something of a highlight and we continue to remember our late organist David Knight whose inspiration this was. A huge thank you to you all.

Besides this, the diocese appointed a new Bishop — one of whose first tasks was to participate in the enthronement of the King. He came to visit us in December during the floods and met the majority of the joint PCCs who braved the weather.

Contacts

Pastoral work continues with the help of church members who assist with Home Communions, Baptisms, the Singles' Lunches, and Little Seedlings toddler group.

Remembrance Services are well-attended (also at the Titan's Rugby Club).

We continue our modest efforts with younger families. We have 4 schools in which I take school assemblies, on average once a half-term each. We had a Teddy Bears' Picnic, Easter Activity Day and Benefice Picnic as well as ever-popular Crib Services, Animal Service and Carols in churches, barns and on street corners. Each of the churches has a different way to attract people through a range of social activities which maintains our profile within the villages.

In the course of 2023 there have been:

Funerals and crematorium services: 25. Ashes interments: 11

Weddings: 3 plus a full wedding blessing

Baptisms & Thanksgiving for birth of a child: 13 and 1 Thanksgiving

Wider Community

Towards the end of the year the parish council of West Monkton asked me to be part of a bereavement group which they set up in the BACH. Again, relatively modest efforts but still enabling important conversations. Alongside this, I continue as a member of the committee of Cheddon Village Hall and to act as Chaplain to Taunton Titans. We were also asked to hold a commemorative service to mark 80 years since the crash of a Canadian bomber in Broomfield. A remarkable service adorned with a thrilling helicopter flypast and attended by senior Canadian Airforce personnel and others.

Spiritual

We have continued our spiritual and theological journey with the usual round of Lent and Advent groups. This year we have added to these with a Quiet Day, led by Jane up at Broomfield and a series of Reflective Evening Services organised by Alan Cook.

DEANERY

There have been no major vacancies in the deanery this year — except the House-for-Duty at St John's and my 0.5 post here in the SQB. Julian Laurence has been asked to take pastoral charge of a church in Chard while continuing at HT. There is the usual smattering of curates and very helpful retired clergy who assist in various places.

That said, it has been a fairly turbulent time in the deanery. There has been a lot of new housing across Taunton in recent years which is becoming increasingly difficult to cover by the churches. Besides which, the diocese has been mooting a change in the way the Common Fund is calculated and while this has only been announced after the end of Dec 2023, there has been a sense of unease as we have all been aware that something is afoot.

Nationally, it has been known for some time that the energy, finances and resources are being channelled more towards short-term projects (like pioneers and new worshiping communities) in an attempt to boost congregation numbers. This has inevitably detracted from normal parish ministry and led to some stresses locally. It is far from clear whether this strategy is, in fact, increasing numbers or not. The effect has certainly

been to strengthen the churches close to large population centres leaving the country areas less well resourced.

The diocese continues to ask the deaneries to have conversations about prayers for people in same-sex relationships: not with the aim of reaching consensus, but in the hope of finding a way to live with our different perspectives.

Alan Cook has been instrumental in arranging some reflective evening services across the deanery which are starting to bed in as part of our common life together.

Churchwarden's report for year ending Dec 2023

It was pleasing on many levels to start 2023 not dominated by Covid. Although mindful of the need for care our church services were nearly back to normal. We established a regular pattern of a Holy Communion service each Sunday as well as a choral evensong on the fourth Sunday. The Common Cup was shared by those that wished, while others chose to stay with the intincted wafers, all at the altar rail.

The most significant change in the life of our parish in 2023 was that The Rev Mary Styles left Kingston on Easter Sunday to take up a new post in Suffolk. The Benefice was then in an inter-regnum. Bishop Michael subsequently visited and conducted a joint PCC to lay out the timetable for the new appointment. Throughout the next few months our associate vicar Jim worked tirelessly to cover as many services as possible, but even he can't be in two places at once! Several visiting clergy came to our aid as well as a sizeable input from Rev Maureen Doble and later in the year from Rev Jane Eastell with support from our Readers Rosie and Peter; a strong team working together very successfully.

On Oct 4th The Rev Jim Cox was appointed as the new Rector for the South Quantock Benefice. Kingston was honoured to host his licensing by Bishop Michael on Dec 3rd. The result of Jim's full-time appointment is that we have gone from a Benefice of 4 parishes with 1.5 clergy down to 1 with a decision on where in the deanery the 0.5 will be deployed yet to be made thus leaving a Benefice of 4 widely spread churches with one full time priest. Despite this in Kingston we have maintained our regular pattern of services a tribute to our strong clergy team and the organisational wizardry of Michael in the office in organising visiting clergy.

Unfortunately, 2023 was also significant for the number of conflicts in the world and prayers were regularly offered for peaceful outcomes. On 21st January 2023 our bell ringers joined in a national initiative when across the nation bells were rung in support of Ukraine.

Special services for Easter, The Friends, Harvest, Remembrance, and all the Christmas services (carols, crib and The Midnight Communion) were all well attended with refreshments of drinks and/or food supplied by a willing team of helpers.

In terms of the fabric of the church further work has been carried out on the perimeter wall of the old churchyard, a survey has been completed on the tower and work is due to start in March to repair some parts that have become dislodged or just worn by the weather conditions and the age of the stone. The last item to be addressed on the quinquennial report was the stained glass window in the chancel which was showing signs of deterioration in the lead causing stress cracks in the window. This was inspected in Nov and the work scheduled for early 2024. At this point I would like to thank The Friends Group who have financially supported the maintenance of the church fabric and enabled us to keep our wonderful church in good order.

We had two unwelcome visitations this year, firstly a labour of moles continued to dig up both churchyards and so in July we called in a pest controller who caught several moles and all was quiet for the rest of 2023. A second unwanted visitor came in the shape of a large vehicle that impacted with the gatepost at the bottom of the church path causing significant damage. The post had to be taken down and rebuilt but luckily this damage was covered under our Ecclesiastical Insurance Policy. We took the opportunity to replace the gates and a local craftsman built new ones in the style of the old. We were very fortunate that the cost of the gates was covered by the Lewin-Harris family.

On the technical front the church has now got a blue tooth aerial so that music from phones etc can be played through the sound system and thanks to the hard work of our Treasurer we have now got a permanent card reader in church.

Annual services to the clock, the organ, the lightening conductor, the fire extinguishers and the heating system have been carried out and the electrical appliances were PA tested. Between them Jack Councill and Arboricare continue to keep our churchyards immaculate.

Our church is one to be proud of and the numerous comments in the visitors' book give testament to that, but a church is more than the building, it is all the people who make it possible for us to worship here. The choir, the organists, the sacristan, the bell ringers, those who volunteer to read in services, the flower arrangers, the refreshment teams, the cleaners, those that lock and unlock the church and not forgetting the PCC - you all deserve our thanks. If anyone else feels they might be able to help in any of these areas we would love to hear from you.

I would like to re-iterate the delight of the parish as a whole on Jim's appointment and also to register our grateful thanks to Michele, in the office, who goes above and beyond her responsibilities to make life easier in the running of the Benefice.

The required checks including the safeguarding audit have been carried out. The Terrier and inventory are both up to date.

PCC SECRETARY'S REPORT FOR 2023

The committee had 7 scheduled meetings during the year at which issues relating to the day to day running of the church were discussed as well as specific areas of concern mainly associated with the church building. There was a Benefice PCC meeting in April chaired by Bishop Michael and a second one in December following Rev. Jim's installation as Rector.

Membership of our PCC remains at 8 which includes the Rector, Church warden and 2 Deanery Synod members with the Treasurer being ex officio, Margaret Way was elected at the APCM and Lesley MacKay has stepped down in anticipation of her impending house move.

At each meeting there are Rector's, Deanery Synod, Churchwarden's and Treasurer's reports which give points for discussion and action.

Our priorities this year have been:

- Decisions relating to the monthly pattern of services.
- Discussion of the MAP
- Arrangements during the vacancy following Mary's departure.
- Organising work on the churchyard wall, repair of a damaged gatepost and preparing for repairs to the tower.
- Further discussions related to possible re ordering in the church.

Whilst our meetings do cover a wide variety of issues as mentioned above, most of the "real work" is undertaken on a daily basis by the clergy, churchwarden and other committed people to whom we are indebted.

In line with regulations, the PCC is responsible for ensuring we manage the production of a new Electoral Roll within the required timescales in the lead up to the 2025 APCM. I will be in touch with everyone on the current Electoral Roll later in the year about this matter.

At the close of the Annual Parochial Church Meeting additional names may be added to the roll, for which application forms can be obtained from me or from the Benefice Office.

SAFEGUARDING REPORT 2022

We are pleased to report that we have not had to deal with any safeguarding cases in the Benefice during 2023.

PCC members have been working hard at completing the required training. This year the Church of England have added an extra mandatory training course to the list for PCC members to complete which is Domestic Abuse training. Whilst it is a requirement for PCC members to complete this training as well as Foundations safeguarding training every three years, anybody can access the various training courses through the Church of England training portal.

The Parish Dashboards are still being used and a new hub has been included which enables us to track details of DBS certificates and training courses for those who need to complete them. It has a useful feature that reminds us when people's training and DBS checks are up for renewal. The dashboard also allows us to generate a Parish Action Plan for PCCs to approve the various documents, etc that need approving to ensure that we are compliant with our safeguarding responsibilities. Each parish is at a different stages on this journey. Samm is looking after the dashboards for West Monkton and Cheddon Fitzpaine and Lucy is looking after the dashboards for Kingston St Mary and Broomfield.

The Diocese have now started to use a new DBS checking organisation called thirtyone:eight so if you have previously had to complete a DBS check, it will look a little bit different when you have to renew your DBS, but it is quite straightforward to complete.

If anyone has any queries or concerns they wish to discuss with us relating to safeguarding, please get in touch. Safeguarding is everybody's responsibility.

BAPTISM FOLLOW-UP VOLUNTEERS MINISTRY. January 2023 – December 2023.

Our role on behalf of the church is to improve contact and follow -up with families bringing their children for baptism or for a service of thanksgiving.

We have attended the baptisms during the past year welcoming families and guests to the service introducing ourselves as a representative of the church. Often we are also asked to do the reading.

We then make a phone call to the family approx. 4 weeks after the baptism to ask general questions about how the baptism day went and highlight upcoming events and services at the church.

This phone call is a one-off, assuring families then of our details should they need to contact us again.

The baptisms have usually taken place at noon on a Sunday.

Sometimes the church is packed with godparents and sponsors and at other times a small intimate service for the immediate family. When there is an organist requested the singing fills the church and so far the feedback from families is that it is a very special day they will never forget.

Important links are made then with baptism families invited to specific events in the benefice in the future and with those children who go on to attend any of our Church Schools with Rev Jim Cox present at regular school collective worships.


BATHPOOL PIONEER REPORT FOR APCM's


Looking forward, we have a number of children who will be off to school in September, so we will be looking for ways to help them, such as supporting early scissor and fine motor skills.

Our Mission: to know, share and spread the love of God.

Introduction

Christian communities should be places where all are welcomed and feel safe.

All people have the right to:

be treated with respect and dignity
have their privacy respected
be able to lead as independent a life as possible
be able to choose how to lead their life
have the protection of the law
have their rights upheld regardless of their ethnicity, gender, sexuality, impairment or disability, age, religion
or cultural background
be able to use their chosen language or method of communication
be heard.

The commitment of the Benefice

We are committed to the care, nurture of, and respectful pastoral ministry with, all people, and especially with regard to the safeguarding and protection of all vulnerable people (a child, young person or vulnerable adult). We will seek to foster a safe, caring community which provides an environment where there is a culture of informed vigilance regarding the dangers of abuse, and where victims of abuse can report or disclose abuse and find support. We will strive to promote best practice that contributes to the prevention of abuse and we are committed to the national church guidance as laid out in "Promoting a safer church"

The responsibility of the Benefice

The welfare of any vulnerable person is always the primary concern and we will act promptly whenever a concern is raised about a vulnerable person or about the behaviour of any adult in a position of trust or authority. We are also committed to the support of those who have been abused and to listening to the voices of survivors, who can help the church learn lessons from the past. Any allegation, disclosure or statement, something seen or something heard must be recorded and acted upon. Complaints can be taken from alleged victims and third parties.

Areas of responsibility

This Benefice accepts that, through its workers and volunteers, it is responsible for vulnerable people during church activities when in a church building, on church property and other premises being used by the church, and also when in contact with people via social and other media or when home visiting. Responsibility extends to travel between places, when it is organized by the church. However, the church is not responsible for private arrangements.

Whole church responsibility

The safeguarding and protection of vulnerable people is everyone's responsibility, not just parents or those who have formal leadership or caring responsibilities. Procedures and formal processes alone, though essential, will not protect children and adults. The community, including all its members, needs to be aware of the dangers and be prepared to report concerns and take action if necessary.

Recruitment

We will carefully select all those with any responsibility for vulnerable people within the church in line with safer recruitment principles, including taking up references and the use of criminal records checks (DBS). All blemished DBS checks will be referred to the Diocesan Safeguarding Advisor for advice. A clear DBS form does not guarantee the appointment of a volunteer; and a blemished DBS is not an automatic disqualification. All confidential data is kept locked in the benefice office.

It is the policy of this Benefice that if they reach the criteria:

all those who regularly work with vulnerable people including those who work on a rota, should have enhanced DBS checks;

those who work only occasionally will be asked to apply for a DBS check;

those who manage or supervise people who work with vulnerable groups will be required to be DBS plus Barred List checked.

All those recruited must maintain training in line with diocesan guidance.



Independent Examiner's Report to the Parochial Church Council of The Church of St Mary the Virgin, Kingston St Mary

I report to the trustees on my examination of the accounts of the Parochial Church Council (the Council) for the year ended 31st December 2023.

Responsibilities and basis of the report

As members of the Council, you are responsible for the preparation of the accounts in accordance with the requirements of the Charities Act 2011 ('the Act').

I report in respect of my examination of the Council's accounts carried out under section 145 of the 2011 Act and in carrying out my examination I have followed all the applicable Directions given by the Charity Commission under section 145(5)(b) of the Act. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently no opinion is given as to whether the accounts present a 'true and fair' view, and the report is limited to those matters set out in the statement below.

Independent examiner's statement

I have completed my examination. I confirm that no material matters have come to my attention in connection with the examination giving me cause to believe that in any material respect:

- accounting records were not kept in respect of the Council as required by section 130 of the Act;
- 2. the accounts do not accord with those records.

I have come across no other matters in connection with the examination to which attention should be drawn in this respect in order to enable a proper understanding of the accounts to be reached.

Financial Review.

The financial statements attached are correct as of 31st December 2023 by direct comparison with the Bank Statements for the year 2023, also there is complete alignment with fees account, but the general account was out by £3.56 shown as £4.00 in the accounts due to rounding (the bank was higher). Additionally, there is complete agreement with the deposit account based on the statements from CCLA.

Overall, the accounts show a different picture to last year. Firstly, both donations and "other income" were down by approximately £4.5k and £8k respectively. In both cases it is difficult to appreciate why this was. For donations it was no doubt impacted by the numbers at services and the loss of some parishioners. On "other income" there is an accounts coding impact in that some items were coded differently in 2022. Even though "other income" was lower than 2022 in 2023 there were two significant items, the transfer of £4k from the deposit account and the donation for the new gates. This could possibly be more correctly designated a donation or legacy and should be referred to as such but as it went into the accounts and out again over a short time period to pay the gate manufacturer it was coded on the "other income" line. This year income from the "Friends" to cover church wall repairs was gratefully received and a VAT recovery related to various works by Glynns also featured. Whilst last year there were no major works, issues defined as Minor works inflated the Church Running expenses line on the payment side by £8.5k

The Benefice Office activity has continued as normal with no major changes. However, the work by Michele Hardiman during the period between Mary Styles leaving and Jim Cox being appointed was recognised. Last year I reported on the installation of a meter to enable the vicarage electricity use to be measured rather than rely on estimates, this proved very valuable during the period the property was let with the tenant being invoiced directly for power used.

This year the funding of the Benefice Office continued to benefit from an increase in the Legacy from the Joslin Trust which was fixed at £12,800 last year. However, a further one-off payment from Joslin of £250 was received as a gift to Michele for the extra work mentioned above. In April the Church wardens agreed to increase the salary for Michele Hardiman. As normal the Benefice Office activities show a net negative £6,617, which is to be recovered during 2024 from the benefice churches in the proportion split 40,40,10,10.

The Church functioning expenses in total which includes all essential costs (heating, power, insurance, essential maintenance etc.) for the year was £28,246. This approximately equates to the receipts by standing order plus planned giving and gift aid recovery, i.e. we just about "pay our way" but given the reductions reported above going forward this needs to be monitored as it may not always be the case.

At 31 December 2023 the Charity had unrestricted reserves made up of the current account, the deposit account, the investments plus the fees owed from other parishes less the fees account which is restricted, amounting to £322,319 (2022; £298,579). Of these unrestricted reserves £273,997 is held as investments leaving £44,351 of free reserves. This plus our continuing regular donations will provide sufficient free reserves to cover the next 12 months of general Church expenditure.

The 4^{th} Qtr fees for 2023 were paid early in January 2024 therefore at the time of accounts preparation there are no fees owed to other parishes.

The PCC elected to purchase a card machine reader for cashless donations towards the end of 2023. This was acquired at a significantly reduced cost of £90.00 (C of E national initiative). This machine uses a sim card which was part of our telephone contract with BT and has sufficient signal at church. From its installation in November 2023 to the end of year £11.80 had been received in the bank account via this route. However £37.00 had been given via the card reader. The balance was received during services towards the end of 2023 so will appear in the accounts early in 2024.

Year ended 31 December 2023

The accounts have been prepared on the receipts and payments basis and in accordance with Charity Commission guidance.

Neither the Trustees, nor any person connected with them, have received any remuneration. Expenses claimed are paid at cost.

The Endowment Fund represents the land at Lodes Lane shown as a conservative estimate based on Greenslade Taylor Hunt advice. The balance at 31 December 2022 was £37,500 (2021: £37,500).

The Restricted Funds are represented by:

The Benefice Fund, which is managed under the direction of the rector by the Kingston PCC in support of all four churches in the benefice. It aims to break even over the year with the four churches contributing in the ratio of 40,40,10,10 (Kingston, West Monkton, Cheddon, Broomfield).

The **Picture Fund** arises from the sale in 1996 of a painting. Application has been made to the Diocese to transfer the Fund to a Fabric Fund and is pending. Balance at 31 December 2023 £2,445 (2022: £2,445).
